### **MINUTES**

## Regular Meeting

May 16, 2006

The Carroll Consolidated School Corporation met in regular session Tuesday, May 16, 2006, 8:00 p.m. at the Administration Building. Those present were Board members Sam Zook, Edward Johnson, Barbara Payne, and Michael Eikenberry. Susan Budreau was absent. Also present were Superintendent John Sayers, School Attorney Miriam Robeson, Principals Charles Huckstep and Carolyn O'Connell, Assistant Principals Fred Schnarr and Natalie McQuade, Scott Ayres, Eric Johnson, Dave Lambert, Linda Harrold, Susan Abbott, Melissa Keown, Malinda Blocher, Susan Briggs, Sandy Kistler, Karen Stankard, one representative from the news media, and Leslie Allen.

<u>Minutes</u>: Mr. Johnson made a motion to approve the minutes of the regular meeting and executive session held on May 2, 2006. Mr. Eikenberry seconded the motion. Vote 4-0. Motion carried.

Approval and signing of the corporation vouchers, treasurer's report and lunch fund report: Mrs. Payne made a motion to approve the corporation vouchers, treasurer's report and lunch fund report. Mr. Johnson seconded the motion. Vote 4-0. Motion carried.

<u>Certificate of Appreciation</u>: Mr. Zook presented Mrs. Abbott and Miss Harrold with a Certificate of Appreciation for the math team and thanked them for their hard work and dedication.

<u>Physical Education/Reroofing/Kitchen Renovation</u>: Superintendent Sayers discussed the placement of the concession stand. He stated that they may want to move it from the location on the drawing to a site east. Superintendent Sayers stated that they moved trees from the elementary. The Board gave permission for the Superintendent to take bids for the softball/soccer field in June.

<u>Carroll Education Foundation Resolution</u>: Superintendent Sayers read the resolution for the Education Foundation. He asked for approval and signing of the resolution. Mr. Johnson made a motion to approve the resolution as presented. Mr. Eikenberry seconded the motion. Vote 3-0 (Mr. Zook abstained). Motion carried.

Expense Reduction and Recovery Agreement: Superintendent Sayers asked permission to enter into an agreement with Audit Associates to review our utility bills for the past two years. If they find savings in our billing, they will receive 50% of the refund due. Mr. Eikenberry made a motion to approve the request. Mrs. Payne seconded the motion. Vote 4-0. Motion carried.

<u>Volleyball Clinic</u>: Breann Falkenberg requested permission to hold a volleyball clinic June 19-22. Cost to students would be \$15 with proceeds to go toward clinic expenses and the remainder to the athletic fund. Mrs. Payne made a motion to approve the request. Mr. Johnson seconded the motion. Vote 4-0. Motion carried.

<u>Recycling Project</u>: Mrs. Blocher, Mrs. Briggs, Mrs. Kistler, and Mrs. Stankard were present to discuss the recycling project they were involved in this year.

<u>NetSmartz Workshop</u>: Mrs. O'Connell was present to discuss the NetSmartz Workshop. She stated that this project helps educate students and families in how to be safer in their network usage.

<u>Student Handbooks</u>: Mr. Schnarr and Miss McQuade were present to discuss the proposed changes to the student handbooks for both schools. Mrs. Payne made a motion to approve the student handbooks as presented with the proposed changes. Mr. Johnson seconded the motion. Vote 4-0. Motion carried.

<u>Textbook Adoption</u>: Mr. Eikenberry made a motion to adopt the textbooks as presented. Mrs. Payne seconded the motion. Vote 4-0. Motion carried.

<u>Cash Tuition Request</u>: Superintendent Sayers received a letter from Miriam Robeson and David Pickens requesting their three children be approved to continue attending Carroll Elementary on a cash tuition basis. Superintendent Sayers recommended that the request be approved. Mr. Johnson made a motion to approve the request. Mrs. Payne seconded the motion. Vote 4-0. Motion carried.

<u>Summer School Bus Driver Pay</u>: Superintendent Sayers recommended that the summer school bus driver pay be increased to \$40 per day. Mr. Eikenberry made a motion to approve the recommendation. Mr. Johnson seconded the motion. Vote 4-0. Motion carried.

<u>Conference Request</u>: Superintendent Sayers is recommending that Fred Schnarr, Charles Huckstep, Kristen Seward, and Susan Shively attend a conference on Career Pathways June 12-14 in Phoenix, Arizona. Superintendent Sayers stated the cost would be covered by a vocational grant and staff development money. Mrs. Payne made a motion to approve the recommendation as presented. Mr. Eikenberry seconded the motion. Vote 4-0. Motion carried.
